<b>Eligibility</b>	<ul style="list-style-type: none"> <li>• Anyone making an outstanding contribution to Ryerson, even if not a member of the Ryerson Community.</li> <li>• Members of the RFA Executive are not eligible during their term of office.</li> </ul>
<b>Nominations</b>	<ul style="list-style-type: none"> <li>• Call issued by Professional Affairs Committee to entire Ryerson community</li> <li>• received by the Chair, Professional Affairs Committee</li> </ul>
<b>Adjudication</b>	<ul style="list-style-type: none"> <li>• Nominations to be reviewed by a committee consisting of members of the Professional Affairs Committee, the Immediate past-President, if available, and the Vice-President Internal</li> <li>• Recommendation to the Executive requires support of a 2/3 majority of the committee</li> </ul>
